**DECLARATION OF ANDREA M. CANTELM, CHIEF COUNTY SOLICITOR  
FOR BEAVER COUNTY, PENNSYLVANIA IN SUPPORT OF: (A) CLASS  
REPRESENTATIVES' MOTION FOR FINAL APPROVAL OF CLASS ACTION  
SETTLEMENT; (B) CLASS COUNSEL'S MOTION FOR ATTORNEYS' FEES  
AND EXPENSES; AND (C) BEAVER COUNTY EMPLOYEES' RETIREMENT  
FUND'S REQUEST FOR REIMBURSEMENT OF COSTS AND EXPENSES**

I, Andrea M. Cantelmi, hereby declare under penalty of perjury as follows:

1. I am the Chief County Solicitor for Beaver County, Pennsylvania. Prior to being promoted to Chief County Solicitor in February 2016, I served as Deputy Solicitor for Beaver County. I submit this declaration, on behalf of Beaver County Employees' Retirement Fund ("Beaver County"), in support of (a) Class Representatives' motion for final approval of the proposed settlement reached with Defendants in the above-captioned action (the "Settlement"); (b) Class Counsel's motion for attorneys' fees and expenses; and (c) Beaver County's request for reimbursement of costs and expenses incurred in connection with its representation of the Class.<sup>1</sup> I have personal knowledge of the matters set forth in this declaration and, if called upon, I could and would testify competently thereto.

2. Beaver County Employees' Retirement Fund provides retirement benefits for public employees of Beaver County, Pennsylvania. As of December 31, 2016, Beaver County Employees' Retirement Fund had approximately 2,000 current employees and retired participants and over \$290 million in assets under management.

3. By Order dated February 13, 2014, Beaver County was appointed by the Court as one of the Lead Plaintiffs pursuant to the Private Securities Litigation Reform Act of 1995 ("PSLRA"). Thereafter, by Memorandum Opinion and Order dated July 28,

2016, the Court appointed Beaver County, along with Erie County Employees' Retirement System and Luc DeWulf, as Class Representatives for the Class.

**I. Beaver County's Oversight of the Action**

4. I have been the primary person involved, on behalf of Beaver County, in monitoring and overseeing the prosecution of this Action and the negotiations that resulted in the Settlement. On behalf of Beaver County, I had regular communications throughout the litigation with attorneys from Kessler Topaz Meltzer & Check, LLP ("Kessler Topaz") – one of the law firms serving as Court-appointed Class Counsel. Beaver County, through my active and continuous involvement, supervised, monitored, and was actively involved in all material aspects of the prosecution and resolution of the Action. Beaver County received periodic status reports from Kessler Topaz on case developments, and participated in regular discussions with attorneys from Kessler Topaz concerning the prosecution of the Action, the strengths of and risks to the claims asserted against Defendants and potential settlement.

5. In particular, throughout the course of this Action, I:

(a) regularly communicated with attorneys from Kessler Topaz by email, telephone, as well as through in-person discussions, regarding the posture and progress of the Action, including all major litigation strategy decisions;

(b) reviewed all significant pleadings, briefs and correspondence filed in the Action, and provided comments and analysis as needed;

(c) supervised discovery produced by Beaver County, including the production of documents, and written responses to document requests and interrogatories;

(d) prepared for and sat for a deposition, which was taken on February 9, 2016 at Kessler Topaz's offices in Radnor, Pennsylvania;<sup>2</sup>

(e) consulted with Kessler Topaz concerning the settlement negotiations and formal mediation efforts that occurred during the course of the Action and those that ultimately led to the Parties' agreement-in-principle to settle the Action; and

(f) evaluated, approved and recommended approval of the proposed Settlement for \$9,500,000 in cash to Beaver County's board.

## **II. Beaver County Strongly Endorses Approval of the Settlement**

6. Based on its involvement throughout the prosecution and resolution of the Class's claims, Beaver County strongly endorses the proposed Settlement and believes the Settlement is fair, reasonable and adequate to the Class. This Settlement provides a highly favorable recovery for the Class, particularly in light of the substantial risks and uncertainties of continued litigation, including the outcome of the Parties' summary judgment motions that were pending when the Settlement was reached, and trial.

## **III. Beaver County Supports Class Counsel's Motion for Attorneys' Fees and Expenses**

7. Class Counsel's fee request is made in accordance with a retainer agreement Beaver County entered into with Kessler Topaz at the beginning of the case. Moreover, Beaver County has seen Class Counsel's work for the last two and a half years and believes that Class Counsel's request for an award of attorneys' fees in the amount of

24% of the Settlement Fund is fair and reasonable in light of the work Plaintiffs' Counsel performed and the result obtained for the benefit of the Class.

8. Beaver County understands that the PSLRA provides the lead plaintiff the primary role in retaining and overseeing counsel. Beaver County takes seriously its duty as a lead plaintiff to ensure that the attorneys' fees are fair in light of the result achieved for the Class and reasonably compensate Plaintiffs' Counsel for the work involved and the substantial risks they undertook in litigating the Action.

9. Beaver County also believes that the expenses being requested for payment to Plaintiffs' Counsel are reasonable, and represent costs and expenses necessary for the prosecution and resolution of the claims in the Action.

10. Based on the foregoing, and consistent with its obligation to the Class to obtain the best result at the most efficient cost, Beaver County fully supports Class Counsel's motion for attorneys' fees and expenses.

**IV. Beaver County's Request for Reimbursement of Costs and Expenses in Connection with its Representation of the Class**

11. Beaver County understands that reimbursement of a lead plaintiff's reasonable costs and expenses is authorized under Section 21D(a)(4) of the PSLRA, 15 U.S.C. § 78u-4(a)(4). For this reason, in connection with Class Counsel's request for payment of expenses, Beaver County seeks reimbursement of the costs and expenses that it incurred directly relating to its representation of the Class in the Action. These costs and expenses total \$3,142.59, as detailed below.

12. As former Deputy Solicitor and now, Chief County Solicitor of Beaver County, my primary responsibility involves, among other things, monitoring litigation involving Beaver County, reporting on the status of such litigation, serving as counsel to the various boards of Beaver County, Pennsylvania, including Beaver County Employees' Retirement Fund, and assisting the Human Resources Department with various employment matters.

13. The time that I devoted to the representation of the Class in this Action was time that I otherwise would have expected to spend on other work for Beaver County and, thus, represented a cost to Beaver County. In sum, Beaver County seeks reimbursement for the 62.25 hours I devoted to supervising and participating in this Action in the amount of \$3,142.59.<sup>3</sup> The time I spent in connection with the prosecution of this Action, on behalf of Beaver County, included the following tasks, among others: communicating and strategizing with Kessler Topaz; reviewing pleadings, motion papers and other court documents filed on behalf of the Class (including drafts), and documents filed on behalf of Defendants; gathering and reviewing documents in response to Defendants' discovery requests; preparing for and testifying in a 30(b)(6) deposition on behalf of Beaver County; monitoring the progress of settlement negotiations and evaluating the proposed Settlement Amount; and reviewing documents related to the Settlement once it was reached.

**V. Conclusion**

14. In conclusion, Beaver County was closely involved throughout the prosecution and settlement of the claims in this Action, strongly endorses the Settlement as fair, reasonable and adequate, and believes that the Settlement represents a significant recovery for the Class. Accordingly, Beaver County respectfully requests that the Court approve Class Representatives' motion for final approval of the proposed Settlement.

15. Beaver County also supports and respectfully requests the Court approve Class Counsel's motion for attorneys' fees and expenses, and believes that Class Counsel's request for fees and expenses represents fair and reasonable compensation for counsel in light of the Settlement reached, the substantial work conducted and skill displayed by Plaintiffs' Counsel, and the risks of litigation. And finally, Beaver County believes its request for reimbursement of costs and expenses incurred in prosecuting the Action on behalf of the Class is fair and reasonable and warrants the Court's approval.

I declare under penalty of perjury under the laws of the United States of America that that the foregoing is true and correct, and that I have authority to execute this declaration on behalf of Beaver County.
